ACTING DIRECTOR

- Projects:
 - Audio recorder: Upgrading the exiting Stancil audio recorder. Will be looking to schedule the refresh for this in early 2023. Researching grant opportunities for this purchase (\$22,000). Maintenance renewal (\$5,000) on existing system due late May. Targeting May for refresh to save the additional maintenance renewal.
 - Development of Workgroup:
 - Warrant Clerk MOU's
 - ◆ Jeffcom 911 ILA
 - Port of Port Townsend contract and SOP
 - 2/10th of 1% proposal for 2023: Utilizing a public volunteer for assistance on the process and procedure. Also reaching out to other PSAPs.
 - CritiCall: Internal validation testing is being performed. From this, we can baseline scoring of testing modules. Hoping to roll out CritiCall for screening in March.
 - Jeep Grand Cherokee: In process to get deep cleaned before posting to the state auction site.
 - Radio: Fire is requesting a secondary communication channel. There are personnel and equipment challenges that need to be worked out but technology research is being done and talks underway with key stakeholders.
- Budgetary Items:
 - Radio Console Upgrade: Will research and work on budgetary numbers 2023. Objective is to have more interoperability with Pencom and ability to backhaul communications with tower sites if microwave fails.
 - CBA: Reached out to Robert at Teamsters. He has referred me to Rich Stone. Waiting to hear back so we can start talks.
 - Recruiting for dispatch positions: One accepted conditional offer made pending psych. Three more candidates interested. Although we are getting some candidates, we continue looking for options to market Jeffcom better.
 - OT remains high. Averaging 88 hours/mo/dispatcher with one averaging over 100 hours/mo.
 - Pub Ed: Worked with Keppie to get some bullet point handouts created. She has agreed to take these with her when attending Pub Ed events for EJFR.
 - GIS position: We continue to use Alex. Pencom is posting for a GIS tech. There may be opportunity to utilize that resource in the future streamlining changes getting into the CAD system.

- Health, Safety and Quality of Life:
 - Reached out to the served agencies asking for feedback when Dispatchers do exceptional work so they can be recognized for their actions.
 - As stated earlier we need to get more personnel onboard to alleviate OT and give people some time off to recharge.
- External Relationships:
 - User Group meetings: No user group meeting was held this month.
 - Port of Port Townsend: Talks continue as we work on details of services asked and how we can facilitate with the CAD system and current staffing levels.
 - Icom911: In talks about leasing space to Icom911 at our Maynard tower site.
- ✤ Additional Items:
 - The strategic plan currently being worked on has the following items:
 - A) Review of contracts to ensure accuracy and necessity.
 - B) Costs and timelines for upgrade to: Stancil recording system, radio consoles and shelter at the Coyle tower site.
 - C) Filling of 5 vacant dispatch positions.
 - D) Conducting a full asset inventory of all Jeffcom equipment.
 - E) Creation of proposal for 2/10th of 1% tax increase to help fund operational costs, but the radio replacement/upgrade.
 - F) Address agency needs such as additional repeated and recorded channel for fire.
