IX. User Agency Report: Limited to 10 min per agency

- A. City of Port Townsend Chief Olson
 - i. New Deputy Chief begins July 3rd as well as a new Sergeant.
 - ii. 2 sergeants in Patrol now. 2 ready to go to the academy.

B. QFR - Chief McKern

- i. Fire Season is coming early this year. Red bull's eye is on WA State
- ii. Biggest challenge in June on the Wildland fireside is the partnerships with DNR and NFS; full staffing is July 1st.
- iii. South end is training with law, and helicopter training this Saturday.

C. EJFR - Chief Black

- i. EJFR and District 2 is anxiously waiting to hear back in the next 90 days on the SAFER Grant funding; EJFR is hoping for another 24/7 "engine company" (6 personnel additions) 3 shifts; Daily minimum staffing would move from 13 to 15 fully staffed at District 1.
- ii. Community Risk Specialist, Volunteer Coordinator positions are similarly awaiting funding.
- iii. Cares Unit increased staffing on Wednesdays; 2 units active around the county, of the multi-user vehicle.

D. JCSO – Chair Andy Pernsteiner

- i. Active shooter training at the Quilcene School this weekend: EJFR, Quilcene Fire, Brinnon Fire, Fish & Wildlife, WSP, City of PT. Going forward this will be continued at rotating locations.
- E. Jeff County Greg Brotherton commented about 4th of July burn band. Fire Departments have new authority this year. What is the plan? Tim McKern said that's effective when it switches to Extreme, from Moderate.
- F. Because of the varying weather patterns in our big county, this will give the local Fire Departments more authority in the local jurisdiction.
